REY MAGNERIO STRIKES GOLD



After finishing a gallant third behind Libertad in the Group 1 Winterbottom Stakes (1,200m) on Nov 29, the Magnus six-year-old gelding stayed in Western Australia.

Rey Magnerio thrived when stepping up to the 1,400m for the first time in the Group 3, The Gold Rush at Ascot on Dec 13.

The Robbie Griffiths-trained six-year-old passed his first test on the 1,400m trip with flying colours at his 26th start.

Rey Magnerio, sired by Magnus and the Testa Rossa mare Luchardo, was sold directly from the paddock as a late two-year-old. The astute bloodstock agent Peter Ford facilitated the sale to the Cranbourne training duo of Robbie Griffiths and Mathew de Kock.

In 2016, Andrew and Jody Nitschke acquired Luchardo online for just \$1,000, and Rey Magnerio has proven to be her standout progeny, accumulating earnings exceeding \$2 million to date. Can't wait for his next start!

Members of Thoroughbred Breeders Australia (TBA) may have noticed recent media coverage regarding announcements from the Asian Racing Federation (ARF) and discussions about Australian black type.

The ARF has stated that, due to what they call "exceptional circumstances," the Asian Pattern Committee (APC) will temporarily take over decision-making responsibilities for Australian black-type races.



It is with great sadness and heartfelt condolences that I announce the peaceful passing of Kerry O'Brien, aged 79, on December 13th, 2025

Kerry served as the President of Thoroughbred Breeders South Australia and held the position of Federal representative from 1991 to 1996. Additionally, he was a dedicated member of the Committee from 1989 to 1997, demonstrating unwavering commitment to sustaining the association during challenging financial

periods. He also managed Kildare Park Stud for a time. Kerry will be fondly remembered as the breeder of many high class horses including the triple Group 1-winning mare Forbidden Love, SA Bred Horse of the Year 21/22 as well as exciting 2yo filly Augusta Proud, a winner of the Magic Millions Adelaide 2YO Classic followed by the Magic Millions 2YO Classic on the Gold Coast and the Magic Millions - all in all she won her first six starts as a juvenile.

In his earlier days, Kerry was an outstanding sportsman, representing Australia at the 1966 Jamaica and 1970 Edinburgh Commonwealth Games, and the 1968 Mexico and 1972 Munich Olympic Games. He also competed at the 1969 and 1973 Pacific Conference Games.

Kerry had a tremendous start to his international career where he would rise to athletics fame during the 1966 Commonwealth Games, held in Kingston, winning the silver medal in the Steeplechase. He was also highly successful on the US indoor circuit, setting an indoor World Record for 2 Miles in San Diego in 1971, where he had a time of 8:19.2.

Kerry's contribution to Australian and international athletics was significant and enduring. His outstanding achievements were formally recognised with his induction into the Athletics SA Hall of Fame in 1998 and the Sport SA Hall of Fame in 2014.

He will be deeply missed, and our heartfelt sympathy goes out to his family.
