Racing Australia's one-off amnesty for late Foal Ownership Declarations (FODs) has ended. Understand your obligations under the traceability rules to help ensure the welfare of all Thoroughbreds. Changes with broodmares, stallions, foal declarations, named horses and retired horses.

Racing Australia recognises that ineligibility to register and race your horse in Australia is a serious consequence for owners failing to comply with their lodgement obligations. However, enforcement of the Rules is paramount to ensuring ongoing improvements in horse welfare and traceability. Please follow this link for expanded obligations.
